

TERMS AND CONDITIONS OF MARINA BAY SANDS ARTSCIENCE MUSEUM SOCIAL MEDIA "BE A CREW MEMBER ON SPACESHIP EARTH" GIVEAWAY ("Giveaway")

By submitting your entries for this Giveaway, you shall be deemed to have accepted the following Terms and Conditions of the Giveaway.

Marina Bay Sands Pte Ltd ("**MBS**") is the organiser of the Giveaway. This Giveaway and promotion is in no way sponsored, endorsed or administered by, or associated with Facebook and Instagram. By participating in this Giveaway, you agree to: (a) release Facebook and Instagram from any responsibility and (b) use their respective terms of use.

1. **Terms.** The terms and conditions herein ("General T&Cs"), and any other applicable specific terms and conditions relevant to this Giveaway ("Other T&Cs"), together with any amendments as may be made from time to time, shall form a legal agreement between MBS and you. By participating in this Giveaway, you confirm that you have read, understood and agree to be bound by the General T&Cs and Other T&Cs (collectively, the "Rules").

2. **Eligibility and Participation.**

- a. To be eligible to participate in the Giveaway, each entrant must meet the following basic criteria:

- i. be 13 years of age or older as of the date of entry into the Giveaway; If you are considered a minor, you represent that you have your parent or guardian's permission to enter this Giveaway;
