Terms & Conditions (Promotion)

- 2. All registered Sands LifeStyle ("SL") members who register at any SL counter in Marina Bay Sands Pte Ltd. ("MBS") and are in good standing (each, a "Member" and collectively, "Members") are eligible to participate.

- 4. During the Promotion Period, Members must present their SL membership card upon making payment and utilize Cash / NETS / Credit Card / Debit Card as the mode of payment at the selected Sands participating F&B outlets to earn additional Resort Dollars.
- 5. Only transaction(s) made within the Promotion Period will be eligible for Bonus Resort Dollars upon activation.
- 6. All Bonus Resort Dollars will be credited into the respective Members' accounts within 48 hours of the transaction, or such other time as MBS may determine in its sole discretion.
- 7. Bonus Resort Dollars will not be retroactively credited for Members who do not meet the Promotion requirements.
- 8. Bonus Resort Dollars earned will expire on first-in-first-out basis after 12 months if not used or redeemed.
- 9. Eligible Members who fail to comply with any of the Promotion Terms & Conditions or determined to have abused such Promotion Terms & Conditions will have their Bonus Resorts forfeited. MBS reserves the rights to disqualify any Bonus Resorts that it deems invalid.



Terms and Conditions (General)

- 1. **Terms.** The terms and conditions herein ("General T&Cs") and any other applicable specific terms and conditions relevant to this Promotion ("Other T&Cs"), together with any amendments as may be made from time to time, shall form a legal agreement between Marina Bay Sands Pte. Ltd. ("MBS") and you. By participating in this Promotion, you confirm that you have read, understood and agree to be bound by the General T&Cs and Other T&Cs (collectively, the "Rules"). In the event of any conflict or inconsistency between these General T&Cs and the Other T&Cs, the Other T&Cs will prevail followed by the General T&Cs.
- 2. **Promotion Period.** The Promotion Period will be from 12 Jun 3 Aug 2023, from Monday to Friday (from 11am 3:30pm, both times included). This Promotion will expire at the end of the Promotion Period at which time, no further participation in this Promotion will be permitted.

3. Eligibility and Participation

- a. MBS reserves the absolute discretion to determine the eligibility of any Eligible Member who is eligible to participate in the Promotion. Such determination is final and conclusive, and MBS is not obliged to give any reason for excluding or disqualifying any SL member from participating in the Redemption. No correspondences will be entertained. Only members in possession of SL membership cards with their names and photographs printed on the card will be able to participate in the Promotion. By participating in the Promotion, SL members will be deemed to have read, understood and agreed to be bound by these rules and any other requirements set out in any related promotional material and all amendments, additions, replacements, modifications as may be made from time to time. Eligible Members who fail to comply with any of the Rules will have their eligibility forfeited.
- b. To be eligible to participate in the Promotion, you must:
 - i. be a SL member and be eighteen (18) years of age or older.
 - ii. satisfy any other eligibility criteria determined by MBS in its sole discretion ("Qualifying Participant") and
 - iii. make the Redemption in person.
- c. If you are not an Eligible Member, and have participated in this Promotion, MBS reserves the right to disqualify your participation as well as seek the return of any payment, award or prize (including such payment, award or prizes credited to any of your membership accounts with MBS) from you.
- d. MBS further reserves the right to disqualify your participation in this Promotion if:
 - iv. you have cheated or committed a fraud;
 - v. tampered or attempted to tamper with the entry process/operation of this Redemption;
 - vi. manipulated or attempted to manipulate the operation of this Redemption;
 - vii. your conduct is in breach of the Rules including providing false information (such as fake accounts, personas or photos) or deliberately withholding information; or
 - viii. You do not make the Redemption in person.

4. Resort Dollars Collection.

i. If a SL member accumulates more than the maximum S\$100,000 Resort Dollars as a result of accepting the Bonus Resorts, SL member agrees that Resort Dollars in excess of S\$100,000 will not be credited to SL member's account in accordance with SL Terms and Conditions. Accrual of Resort Dollars will cease and resume only when SL member's account balance falls below S\$100,000 Resort Dollars.



5. Publicity and Intellectual Property.

By participating in this Promotion, you agree to MBS or any of its related companies (collectively, the "Company"), the Company's agents and third party service providers and governmental and regulatory authorities (whether located in Singapore or elsewhere) (collectively, the "Parties") to collect, use, store, disclose to the Parties, and/or broadcast via any corporate and public media platforms in any jurisdiction ("Use") your personal data as collected by MBS from time to time (the "Data") for the purposes of:

- ii. complying with the Company's internal policies, any applicable law/regulation and request/direction of any applicable authorities of any relevant jurisdiction that is binding on the Company; and
- iii. marketing and advertising the Company's business within and outside of Singapore. For this purpose, you grant MBS a licence to Use your personal data, including your images and likeness, and waive all claims for payment for such Use.

6. MBS Liability.

- . MBS will not be responsible for (i) electronic transmission errors or delays resulting in your inability to participate or other loss, (ii) theft or destruction of or unauthorised access to or unauthorized alterations of materials, or technical, hardware, software failures of any kind, (iii) lost or unavailable connections, or delayed computer transmissions, whether caused by MBS, users, or by any of the equipment or programming associated with or utilised in this Promotion or by any technical or human error which may occur in the processing of submissions which may limit, restrict, or prevent your ability to participate in this Promotion, or (d) any loss of opportunity to participate in this Promotion for any reason whatsoever.
