

#### **MBS & WTA FINALS LUCKY DRAW**

## **General Terms and Conditions**

Marina Bay Sands Pte Ltd ("MBS") is the organizer of the WTA Finals & MBS Lucky Draw (the "Promotion").

- 1. **Terms.** The terms and conditions herein ("General T&Cs"), together with any amendments as may be made from time to time, shall form a legal agreement between MBS and you. By participating in this Promotion, you confirm that you have read, understood and agree to be bound by the General T&Cs.
- 2. **Promotion Period.** The period of this Promotion will be from 19 October 2018 to 23 October 2018 ("Promotion Period"). This Promotion will expire at the end of the Promotion Period at which time, no further participation in this Promotion will be permitted.
- 3. Eligibility and Participation.
- a. To be eligible to participate in the Promotion, you must:
  - i. order any tennis-themed cocktails at The Bird Southern Table & Bar from 19 October to 23 October 2018;

  - iii. not fall within any of the following categories of persons: (v) advertising agencies (and affiliates) of MBS or MBS Retail Management Company Pte Ltd ("MBSRM"); (w) employees of MBS tenants; (x) employees of MBS, MBSRM and their immediate family members; (y) employees of WTA Tour Inc ("WTA"); and (z) employees of Lagardere Sports Asia Pte Ltd ("LSA"); and
  - iv. be at least 18 years of age at the time you submit the Entry Form.

("Qualifying Participant").

- b. If you are not a Qualifying Participant and have participated in this Promotion, MBS reserves the right to disqualify your participation as well as seek the return of any payment, award or prize from you.
- c. MBS further reserves the right to disqualify your participation in this Promotion if:
  - i. you have cheated;
  - ii. tampered or attempted to tamper with the entry process;

  - iv. you have submitted more than one (1) Entry Form; or
  - v. your conduct is in breach of the General T&Cs including providing false information (such as fake accounts, personas or photos) or deliberately withholding information.

  - Session 9 (Saturday 27 October 2018, 1:30pm Doubles Semi Final, 4:00pm Singles Semi Final);
  - ii. Session 10 (Saturday 27 October, 7:30pm Singles Semi Final, Followed by Doubles Semi Final); or
  - iii. Session 11 (Sunday 28 October, 4:00pm Doubles Final, then Singles Final)



(each, a "Prize")

- c. The Winning Participants and the corresponding Prize will be selected at random.
- d. Winning Participants must accept the relevant Prize "as is". Prizes cannot be exchanged for other Prizes or cash, are non-transferable, non-exchangeable, non-reimbursable and may not be sold or used for any commercial purpose, including but not limited to any use for which the Winning Participant would be entitled to collect fees or receive any remuneration. Seat selection is not available.
- e. The Winning Participant is solely responsible for the payment of any applicable tax in relation to the relevant Prize and for any costs associated with the Prize or its use.
